WHEREAS, the undersigned now intends to amend certain portions of the Declaration.

NOW THEREFORE, for valuable consideration and in compliance with the Amendment requirements of the Declaration, the undersigned Developer does hereby amend the Declaration as follows:

1. ARTICLE I, DEFINITIONS, PARAGRAPH 8 shall be modified and restated as follows:

"Developer" shall mean and refer to KW GROUP, LLC, a Tennessee limited liability company, having its principal place of business in Murfreesboro, Tennessee, its successors and assigns. "Developer" may at times be referenced herein as "Declarant."

- 2. ARTICLE V, ASSESSMENTS, PARAGRAPH 2, shall be modified and amended in all respects necessary to reduce the Working Capital Assessment to \$200.00.
- 3. ARTICLE XII, GENERAL PROVISIONS, PARAGRAPH 2, shall be modified and amended as follows:

Amendment. The covenants and restrictions contained in this Declaration may be amended unilaterally by the Developer, without joinder of any Owner, until December 31, 2020. Thereafter, any amendment of this Declaration will require the affirmative vote of at least two-thirds (2/3) of the Votes entitled to be cast by the then Members of the Association (both Class A and Class B) at a duly called meeting of the Association at which a quorum is present. To the extent then required by applicable laws and/or regulations, all amendments of this Declaration must be approved by the Planning Commission of the City of Murfreesboro and Rutherford County, or its successor governmental entity.
