**SUPPLEMENTAL DECLARATION OF COVENANTS, CONDITIONS AND

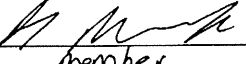

Any and all Owners of Carlton Landing, Section 1, Phase 2 shall be subject to the restrictions, regulations, conditions, covenants and plans as provided in the Declaration of Covenants, Conditions and Restrictions for Carlton Landing, Section 1 of record in Record Book 2054, Page 2980 of the Register's Office of Rutherford County, Tennessee, and any and all amendments, if any, and as amended hereinabove by this instrument.

3. Any and all Owners of Carlton Landing, Section 1, Phase 2 shall be members of the Carlton Landing Homeowner's Association, Inc. and be subject to, and entitled to the benefits of the Association as established in the Declaration of Covenants, Conditions and Restrictions for Carlton Landing, Section 1, Phase 2 stated herein above.

Cornerstone Development, LLC reserves the right to unilaterally amend this Supplemental Declaration of Covenants, Conditions and Restrictions to Carlton Landing, Section 1, Phase 2 so long as Cornerstone Development, LLC owns any unit within Carlton Landing, and for a period of five (5) years from the sale of Cornerstone Development, LLC's last unit in Carlton Landing by the Developer.
