SUPPLEMENTARY DECLARATION OF RESTRICTIVE COVENANTS,

CONDITIONS AND RESTRICTIONS APPLYING TO

SECTION 2, PHASE 2, LIBERTY COVE SUBDIVISION

The undersigned, **LIBERTY HEIGHTS, L. P., a Tennessee limited partnership** ("Declarant"), being the owner of a parcel of real property known as **SECTION 2, PHASE 2, LIBERTY COVE SUBDIVISION**, of record in Plat Book 39, page 219, in the Register's Office of Rutherford County, Tennessee, does hereby desire to subject the property known as **SECTION 2, PHASE 2, LIBERTY COVE SUBDIVISION**, to the same restrictions as for **LIBERTY COVE, SECTION I**, previously recorded in the Register's Office of Rutherford County, Tennessee in Record Book 1321, page 2544, and any further amendments thereto.

NOW, THEREFORE, in consideration of the foregoing, it is agreed as follows:

1. SECTION 2, PHASE 2, LIBERTY COVE SUBDIVISION, as shown on plat of record in Plat Book 39, page 219, in the Register's Office of Rutherford County, Tennessee, shall be subject to the same Restrictive Covenants applying to Liberty Cove, Section I, as same appear of record in Record Book 1321, page 2544, and any further amendments thereto.

2. Any and all lot owners of the property described herein shall be subject to the restrictions, regulations, conditions, covenants and plans as provided in the Restrictive Covenants for Liberty Cove, Section I, of record in Record Book 1321, page 2544, and any further amendments thereto. It is the intent of the undersigned that SECTION 2, PHASE 2, LIBERTY COVE SUBDIVISION, be governed by the same restrictions applicable to Liberty Cove, Section I.

3. The Declarant reserves the right to unilaterally amend the restrictions to SECTION 2, PHASE 2, LIBERTY COVE SUBDIVISION, so long as it is the owner of any lots within SECTION 2, PHASE 2, LIBERTY COVE SUBDIVISION.

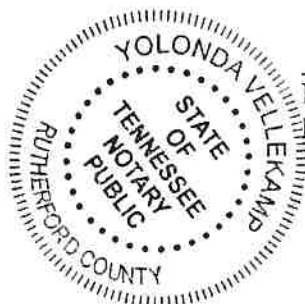
